**NOTIFICATION**

The guidelines and criteria for promotion under the Career Advancement Scheme (CAS) for Incumbents (Teachers and equivalent positions/ Librarians/ Directors of Physical Education and Sports and equivalent position) have been prepared by the committee constituted by the University orders Estt. I/RC/CAS/567-568 and Estt. I/CAS1121 on June 6, 2022, and November 23, 2022, respectively. The guidelines for Career Advancement Scheme (CAS) are in accordance with the UGC regulations on minimum qualifications for the appointment of teachers and other academic staff in universities and colleges, and measures for the maintenance of standards in higher education, 2018 (The Gazette of India Extraordinary Part-III section 4, published by authority, New Delhi, Wednesday, July 18, 2018), along with all subsequent amendments and ICAR Letter No. 1(4)/2017-Per IV Dated 27 March 2018.

To avoid hardship to those faculty members who have already qualified or are likely to qualify till 31st December 2024 as per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education, 2010, a choice is given to them either for being considered for promotions under the 2010 or 2018 Regulations. The date of eligibility shall be retained as the date of promotion. On the date of submission of the application, the candidate should fulfill all eligibility criteria required for promotion. (The Gazette of India Extraordinary Part-III section 4, published by authority, New Delhi, Tuesday August 1, 2024 and Friday, June 7, 2024)
