Terms and Conditions:

A. Job requirement

1. *Commiphora wightii* plants are found in ravines, isolated patches or in deep forests in Morena district of MP. The project is an extensively field oriented requiring whole month of travelling and stay in Morena for collection and tagging of *C. wightii* plants. Only those candidates willing to travel extensively in forest areas during the Project period for collection of samples during the project period need to apply.
2. Job requires computer knowledge.
3. Period of contract service is upto three months or *co-terminus* of the project, whichever is earlier.
4. The above positions are purely temporary and subject to satisfactory performance. The selected candidate will have no right/claim for regular appointment or absorption in JNKVV at any point of time.

B. Application and fee

1. Only Indian citizens and qualified person (see qualification) shall be eligible for appearing in the online interview.
2. Maximum age limit is 35 years for men and 40 years for women as on last date of submission of application.
3. The eligible and interested candidates are requested to send their duly filled and signed scanned copy of Application in the prescribed format, affixing a passport size photograph on the top with self-attested all supporting documents/certificates only through email to recruit.mpsbb2021@gmail.com to receive on or before **23.10.2021 at 5:00pm.**

4. Supporting documents attached should be in the sequence as given in checklist. Applications not found in prescribed format along with desired documents as per checklist is likely to be rejected.
5. Application fee is Rs.100/- (Rs. One hundred only). The fee may be deposited in favour of The Comptroller, JNKVV in the current account no. 20030700000001 of UCO Bank, JNKVV branch, Jabalpur IFSC: UCBA0002003. The copy of the evidence of RTGS/NEFT/any other transaction may be attached with the application. All applications without the copy of transaction receipt will not be entertained. Candidates belonging to SC/ST are exempted from the application fee.
6. Original documents of the selected candidates will be verified before joining and if discrepancies found his/her document then the selection will be cancelled.
7. Person already in employment should submit “No Objection Certificate” from their present employer at the time of joining.
8. Concealing of facts or canvassing in any form shall lead to cancellation of candidature or termination.

C. Interview

1. The interview for the above post will be conducted online at Directorate of Research Services. Google meet link will be shared later through phone/email or whatsapp.
2. No TA/DA will be paid/provided for appearing in the interview.
3. Only the candidates having prescribed qualifications will be considered for interview.
4. Final selection will be based on marks of both academic as well as interview marks as per the approved score card.
5. The selected candidates will be required to produce all original documents for verification at the time of Joining.
6. The selected candidate will be required to produce medical certificate at the time of joining.

D. Emoluments

1. The selected candidates will be given (i) fixed emolument of Rs.25000/-pm only, (ii) there is no provision for HRA in the project for Project Fellows, (iii) TA/DA of Project Fellows will be as per JNKVV rules.

E. Jurisdiction

1. The Director Research Services, JNKVV reserves the right to cancel/postpone the interview without assigning any reason thereof.
2. The decision of the Director Research Services, JNKVV, Jabalpur will be final and binding on all aspects.
