- 1. These testing charges will be applicable from 01.04.2024 and will remain in force till 31.03.2025. Competent Authority reserves the right to amend the prevailing rates without assigning any reason thereof.
- 2. GST will be charged as per the rates notified by Govt. of India.
- 3. Both testing charges and GST are subject to revision by the respective Competent Authority from time to time.
- 4. Once the machine is submitted for full test and the test fee as required is deposited with the Institutes and subsequently if the manufacturer/applicant withdraws the machine from test, there shall be no refund of test fee.
- 5. These rates are for commercial testing of the equipment.
- 6. Two separate Demand Draft has to be submitted. One for testing charges and another for GST.
- 7. Testing charges to be paid in advance through DD drawn in favor of "RF FMTC JNKVV JABALPUR" payable at JABALPUR.

8. GST to be paid in advance through DD drawn in favor of "RF FMTC JNKVV JABALPUR" payable at JABALPUR.
