1. Name of Post : Dean, College of Agriculture (post for College of Agriculture, Powarkheda)

2. Scale of Pay : Rs.37400-67000+AGP 10000/-

3. Qualifications :

Essential:-

- (i) Bachelor degree with atleast 6.00 OCGA out of 10.00 point scale or equivalent (Trimester/ Semester System) or atleast 50% marks (Traditional System); and
- (ii) A Masters degree in relevant subject with the minimum requirements of a good academic record, 55% marks (or an equivalent grade in a point scale wherever grading system is followed) .
- (iii) Doctoral Degree in the relevant subject in any branch of Agriculture Science or related field.
- (iv) At least 5 years experience as Professor/Principal Scientist or an equivalent position in any branch of Agriculture Science in the scale of Rs.37400-67000 + AGP 10,000.
- (v) Evidence of contribution to research/teaching/extension education as supported by published work in high impact journals/ innovations.
- (vi) Experience in research/ teaching/extension management with evidence of Scientific Leadership vision perspective on Agriculture.
- (vii) A minimum score as prescribed in score card.

**Note:** Reservation, Relaxation, Terms & Conditions, duties etc. as Stipulated by J.N.K.V.V. from time to time.

4. Knowledge of teaching/working in Hindi is essential.
5. Applicants must have requisite qualifications and experience atleast on the last date of receipt of the applications.
6. Subjects to the provisions of ACT and the Statutes of the VishwaVidyalaya the conditions of service of the Dean, of the College of shall be those embodied in the contract of the service prescribed by the VishwaVidyalaya for officers.
7. The Board may if so recommended by the selections committee and for reasons to be recorded in writing for acceptance of such recommendations sanction a higher initial salary than prescribed but not exceeding five advance increments to any candidates.
8. The Dean of the College shall be whole time salaried officer of the V.V. and shall be entitled to leave, leave salary,allowances and other benefits as prescribed in this behalf by the Board from time to time for its employees. Provided that if a candidate from outside the services of the VishwaVidyalaya is appointed to the post the period of his appointment shall be for such a tenure and subject to the conditions as may be determined by the Vice-Chancellor. Such as candidate unless selected for another suitable post during the prescribed tenure will have no claim on any other post in the VishwaVidyalaya after the expiry of the specified tenure.
9. The post of the Dean is interchangeable with that of any of the Directors and Dean, Student Welfare provided the requirement of minimum qualifications is fulfilled.
10. Applications shall be submitted on prescribed format form as per advertisement to the Registrar, JN Krishi VishwaVidyalaya Jabalpur 482004 (M.P.) alongwith Bank Draft of the value of Rs. 1000 dully crossed and endorsed/drawn in favor of Jawahar Lal Nehru Krishi VishwaVidyalaya, Payable at Jabalpur.
11. Candidates from abroad can apply on plain paper giving details of their qualifications experience, minimum salary acceptable and probable date of return to India.
12. Applications not accompanied by applications fee shall be rejected.
13. The application fee shall not be refunded in any case.
14. Summary sheet, as per the format supplied along with blank application form, may be prepared and should be submitted in **QUADRUPLICATE**. It should be prepared with due care as the same will be submitted to the Screening Committee/Selection Committee along with applications for consideration.
15. Persons already in service must apply through proper channel. However, to avoid delay, advance copy of application may be submitted so as to reach the Registrar in time i.e.11.09.2017
16. Applications, complete in all respect, should reach the Registrar latest by the prescribed date for submission of application i.e. 11.09.2017
17. The Candidates shall be required to present themselves, if called for interview. The SC/ST candidates will be allowed travelling allowances as per rules of the M.P. State Govt.



- 18 The Vishwa Vidyalaya reserves the right to increase/decrease or not to fill in the posts and/ or not to call any of the applicants for interview.
- 19 Canvassing in any form and / or bringing any influence, directly or indirectly, will be a disqualification.
- 20 The Vishwa Vidyalaya will not be responsible for any postal delay.
- 21 Any addition / alterations in applications shall not be entertained after last date of submission of the application forms.
22. The selected candidates will be only entitled for pension under new pension scheme 2005 of the M.P. State Government. However the employees already in J.N.K.V.V. services shall entitle to the pension scheme applicable to him/her in this VishwaVidyalaya.

As per Statute 20 (3), it shall be the duty of the Dean of the College :

- (a) to exercise overall control of the College of which he is the administrative and academic head in respect of all employees, students, activities, facilities and the expenditure incurred therein ;
- (b) to supervise the teaching, research and extension work of the staff of the College and be responsible for the work and conduct of all the students of the College ;
- (c) to be responsible to the Vice-Chancellor through the Dean of the Faculty and the Director concerned, in exercise of the powers and discharge of duties under this Statute ;
- (d) to exercise such powers and discharge such duties as may be delegated or entrusted to him by the Vice-Chancellor in regard to the College of which he is the Dean and to be responsible in all technical and administrative matters related to teaching, research and extension etc. through the Dean of the Faculty and Director concerned ;
- (e) to undertake teaching, research and extension by himself ;
- (f) he shall be responsible for the due observance of the Statutes and regulations ;
- (g) he shall supervise the registration and progress of the students in his College.
- (h) he shall formulate and present policies on Academic matters pertaining to his college to the Faculty/ Academic Council for consideration through the Dean of Faculty/ Director of Instruction
- (i) he shall be responsible for proper administration of Research Station/ Instructional Farm/ Institutions attached to the College ;
- (j) he shall be also responsible to the concerning authorities for the use and maintenance of lands, buildings, laboratories, libraries and such other properties of the College, the Research Station/ Instructional Farm and other Institutions attached to the College ;
- (k) he shall be responsible for the maintenance, supervision, functioning of the hostels of the College ;
- (l) to be responsible for the procurement of stores, equipments and such other items as are necessary for the College and units attached with the same ;
- (m) to be responsible for the maintenance of high standard of discipline in the institutions under him ;
- (n) to be responsible for the maintenance of high standard of financial discipline in the institutions under him ;
- (o) to assist the Dean of the Faculty for all policies and programmes related to teaching, research and extension work in the college on co-ordinated basis ;
- (p) to prepare proposals for college activities and budget estimate for the needs thereof and be responsible to the Comptroller through the Vice-Chancellor, that all college activities are in accordance with sanctions of the appropriate authorities ;
- (q) to assist the Director of Research Services on the development of plans and budgets for research in the pertinent subjects and in the preparation of reports as may be asked by him and also direct the research work done by the College staff and students and under the schemes attached with the institutions under him ;
- (r) (i) to assist the Director of Extension Services on development of plans and budgets for extension work in the institutions under him ;  
(ii) to assist the extension services on the development of informational materials ; and  
(iii) to direct the extension education work done by the college staff ;
- (s) to assist the Director of Instruction and direct the works of post-graduate students in his college.
- (t) to be responsible to the Vice - Chancellor through the Superintendent of Physical Plant for the educational use of the buildings and rooms assigned to the college and for the general equipment of the college ;
- (u) to perform such other duties as may be conferred or imposed on him by the Statutes, Regulations or by the Vice-Chancellor.
