- i. *Tenderers are requested not to submit financial bid in any envelop. The price bid will be open only after due satisfaction of technical bid on-line.*
- ii. *Tax extra if any must be shown separately in the specified column of the financial bid*

**General Terms and Conditions:**

1. Only the manufacturers (OEM) and their authorized distributors or dealers or agents need to submit their tender. The bidder should submit an **authorization certificate in original on manufacturer's letter head** and from the manufacturer for their authorized dealership. Third party authorization will not be accepted.
2. No person or firm shall submit more than one Tender for the same item. No offer should have more than one model quoted; in case of more than one alternate offer only the first option will only be considered.
3. It is mandatory to provide all the relevant information in *Annexure I*.
4. Broad-based specifications of equipment/items/systems/works etc. are given in *Annexure II*. The tenderer should also take note of the remarks, if any, given there in.

  1. Preferably rate should be quoted in Indian Rupees.
  2. The rates quoted should be for single complete unit with F.O.R. delivery at **JNKVV, Jabalpur campus**. The rates quoted should be inclusive of packing and forwarding charges/loading/unloading/handling charges/freight/full risk coverage insurance, etc. In case of imported goods all the expenses towards custom duty, clearing charges and transportation with insurance will be borne by the firm/tenderer and they must quote the rates **FOR, JNKVV, Jabalpur campus**.
  3. Excise duty/GST/Custom duty (with and without concession certificate) and other levies, if any should be shown separately and the total price of each item should be worked out incorporating the same.
  4. The institute will provide the custom duty exemption certificate, if necessary for the imported instrument on arrival of goods at the port.
  5. Final rate quoted should incorporate all the discounts, Govt. subsidy etc.
  6. Any other charges, such as technical service charges, cost of training, installation charges, etc. if any, should be shown separately for each item and each sub-item.
  7. Prices for the main item along with accessories should be given separately.
  8. All losses during transport will have to be borne by the tenderers.



6. The tender should be accompanied by detailed printed technical literature with specifications, make and model number of each item and each sub-item quoted in the tender. Specifications given in the offer must match to the website and/or printed technical literature or better otherwise the offers shall be rejected.
7. Firm must provide a compliance statement vis-à-vis specifications in a “tabular form” clearly stating the compliance, supported by technical literature with clear reference. This statement must be signed, with the company seal, by the Tenderer for its authenticity and acceptance that any incorrect or ambiguous information found submitted will result in disqualification of the offer.
8. Complete illustrated and descriptive technical details, drawing of mechanical and electrical must be enclosed along with the supply of the machine. Salient features and details of consumables etc. in respect of each item offered should necessarily be furnished with the tender, in the form of a brochure or a duly signed declaration without which the offers will not be considered.

No one shall be exempted from the remittance of Tender Document Cost.
10. **EMD:** The “**Technical Bid**” of the item must be accompanied by **Earnest Money Deposit (EMD)** in the form of Crossed Bank Draft/ Pay Order/ Banker's/ Manager's of any Nationalized Bank made in favour of “**Director, Biotechnology Centre, JNKVV, Jabalpur**”. Without the earnest money in the above form, the offers will be rejected. The EMD in the form of **Firm's Cheque will not be accepted** and the **offers will be rejected**.
11. On approval of the tender, security deposit (10 % of the basic cost of item including accessories) should be deposited in terms of FDR valid for the warranty period of 2 years (two years) at nationalized bank payable to “**Director, Biotechnology Centre, JNKVV, Jabalpur**”. Security deposit will be returned after successful completion of warranty. The security deposit shall have to be submitted at the time of receiving the supply order and the respective EMD will be returned.
12. **The tenderers must provide original guarantee/warranty on manufacturer's letter head of satisfactory functioning of the equipment/system and free service including free replacement of parts for a period of at least 02 years from the date of successful and satisfactory installation of the equipment/system. Breakdown period should be attended within 10 days.**
13. **Payment Terms:** The standard terms and conditions of payment are against delivery only after the successful installation/ demonstration/others and training to the satisfaction of JNKVV authorities. Payment to tenderer will made after deducting applicable taxes at source and for which necessary certificate will be issued. GST as applicable and HS code should be mentioned in tender.
14. **Tender will not be considered if the firm does not supply a copy of the GSTIN & PAN allotted to it. PAN of the owner or any other persons will not be accepted.**
15. **All taxes including Entry Tax, Octroi etc. will be borne by the tenderer/supplier.**
16. Please quote maximum discounted price, as no further negotiations will be made.
17. **No advance payment will be made and documents for goods dispatched sent through bank shall not be accepted.**
18. It is mandatory to quote the latest model of said equipment/machine for lab. Quoted item should not be refurbished instrument. **The unit of the quoted equipment/ machine by the firm must have minimum three or more installed units in India at National laboratories/Research Institute/ Universities.** The tenderer should furnish the names, addresses and purchase details of the users/govt. department etc. of each of the machines/equipment offered.

19. Machines offered should be new and of latest technology. Second hand, rebuilt, refurbished, reassembled or renovated machines shall not be accepted. An affirmation to this effect will have to be made on the tender form. Working power supply of the instrument should be 230V, 50 Hz.
20. Minimum one working demonstration on sight visit and training of equipment is to be provided by supplier/vender as and when required at their own cost.
21. Vendor should be able to demonstrate sensitivity parameter and other features claimed, at our laboratory with real sample.
22. The tenderer should give the details of after sales and supply of spares arrangements available for the machines offered.
23. Supplier should provide the list of items which are covered under consumables. The items not listed in the consumables would be considered as spare parts for the purpose of warranty obligation including replacement/repairs.
24. In the event of a tenderer withdrawing his tender within period of its validity entire earnest money and any other deposit made by him along with the tender submitted shall be forfeited.
25. If the approved tenderer fails to supply required machine, then Director, Biotechnology Centre, JNKVV, Jabalpur shall be at liberty to either re-tender or purchase such machine for next valid tenderer. In such condition the security deposit of defaulter tenderer shall be forfeited and loss incurred to Government shall be recoverable from him as arrear of Land Revenue.
26. Any deviation, variation of non-compliance of the terms and conditions by the tenders shall be considered as a breach of contract and JNKVV reserves the right to forfeit the amount of earnest money and/or security deposit in part or in full and take action as per legal arrangement. Tender which does not comply with any of the conditions is liable to rejection.
27. Prices shall remain unchanged during the contract period or 6 months from the date of commencement of agreement. The rate once approved by the Committee shall not be increased for any reason or under any circumstances such as variation of exchange rates or increase in cost of product or increase in transportation etc. Supplier will be bound to supply on the same rates as quoted in the tender. No claim will be entertained for revision to a higher quantity slab, higher production/clearance slab of excise levy although payable by the manufacturer. The Director may accept revision in price, only in the event of any revision to the basic rate of excise duty, as applicable on the date of agreement, effected by the Govt. of India. A certificate regarding deposit of enhanced excise levy shall have to be furnished by the manufacturer/supplier.
28. If so desired by JNKVV, the bidders shall have to enter into an agreement.
29. On approval of the tender supplier should make the notarized agreement on the Rs. 100 stamp paper that aforesaid "Terms and Conditions" are agreeable to them. This should be signed and stamped in the presence of two witness and purchaser.
30. J.N. Krishi Vishwa Vidyalaya reserves the right to accept or reject any or all offers in full or in part without assigning any reason (s) therefore. It also reserves the right to place and order wholly or in part with one or more than one firm as they may be convenient to JNKVV.
31. Any judiciary matter shall be in Judiciary of Jabalpur only.
32. In case of disputes, decision of Vice Chancellor, JNKVV, Jabalpur will be final and acceptable to all the parties.
33. The Director, Biotechnology Centre, JNKVV, Jabalpur is not bound to accept the lowest or any tender and reserves the right to accept any tender in whole or in part and shall have the right to accept or reject any tender without assigning any reason.

34. The tenders shall have to give an undertaking that the terms and conditions as mentioned above in this tender are acceptable to the tenderers (In Annexure I).
35. Quantity mentioned in **Table No. 01** is tentative and may be changed without assigning any reason as per the requirement of the JNKVV.
36. Installation and trial run should be carried out at the supplier's risk.
37. The supplier shall also undertake that the firm have never been black listed by any Govt/Quasi Government firm in India and no case is pending at present against the firm. This should also be made clear in the tender as a preliminary undertaking.
38. During the erection/commissioning or performance during warranty period, if the machine supplied is found defective, improper or not as per the specification or of inferior quality or is not otherwise in accordance with the contract, then Director shall intimate this fact in writing to the supplier for rectification/replacement of such defective machine at their own cost to the entire satisfaction of the Director. In the event of their failure to do so as above, Director reserves the right to carry out such repair works at the risk and cost of defaulted supplier.

I/We ..... hereby declare that I/We under the contract to supply the equipments shall abide by all the terms mentioned in the Tender Form and conditions of contract laid hereunder :-

### **Conditions of Contract**

1. This contract is for the period from ..... to ..... or maximum 6 months from the date of commencement of agreement for supply of articles mentioned. Director Extension Services will have power to extend the period of agreement.
2. This agreement is made this ..... day of .....between the Director, Biotechnology Centre, JNKVV, Jabalpur (hereinafter called the Competent Authority which expression shall where the context so admits include his successor in the office) of the one part and M/s ..... (hereinafter called the "Firm" which expression shall where the context so admits includes his heirs and successors) of the other part.
3. Whereas the Competent Authority has accepted the offer of the Firm made in their tender Offer No..... for supplying the equipment(s) as per specification(s) and at the price mentioned in the schedule attached thereto and forming part of this contract, and has decided to entrust to the firm the work of supplying the aforesaid equipment(s) not later than ..... as per supply order from the competent authority as per specifications and price subject to the terms and conditions hereinafter appearing;

And whereas, the firm has agreed to supply the said equipment(s) to the competent authority subject to the said terms and conditions.

Not therefore this Agreement witnesses and is hereby agreed to as follows:-

(a) Security Deposit.- (a) The successful tenderer (hereinafter called the firm, which expression shall include, where the context so admits, his heirs, executors and successors) shall, within two week of the receipt by him of the intimation in writing that his tender has been accepted in part or whole, deposit with the Director, Biotechnology Centre, JNKVV, Jabalpur (hereinafter called the competent authority, which expression shall, where the context so admits, include his successors in office), as security for the due performance of the contract, a sum, amounting EMD payable under this contract for the articles agreed to be purchased less the amount of Rs. . . . . . already deposited with the tender as Tender Deposit provided such guarantee normally covers a period of 12 months from the date of commencement of contract i.e. the date which the Firm signs the Agreement. It is further provided that for any breach, non-fulfillment or non-performance of the Agreement during the period of contract, the Competent Authority shall have power to take action to enforce performance of the Agreement.

(b) In the event of deficiency in the value of the security deposit as a result of forfeiture, or for any other reasons, the firm shall within seven days of receipt by him of a notice in that behalf, make up the deficiency.
